General information

When you enrol for an event by Intrface ApS, you submit a request to purchase access to the event. Intrface ApS may reject the request to purchase access to the event without further justification.

Placing an order

When a request for participation in an event has been placed (an order), an e-mail will automatically be sent with a receipt for the submitted request and a copy of these Terms and Conditions. This receipt is not an order confirmation from Intrface ApS, but only an acknowledgement of receipt of the request to enrol for the event. An order confirmation will subsequently be issued and sent to the e-mail address specified when submitting the enrolment request, provided Intrface ApS accepts the request.

The events offered on www.intrface.com are thus only invitations to make offers, and a binding agreement is only concluded when Intrface ApS has issued and send an order confirmation.

Requests to enrol for an evenr are binding for 7 days. If Intrface ApS has not provided an order confirmation within this period, the customer is free to cancel the request at no costs, until the point in time

where Intrface ApS provides an order confirmation to the customer.

No right of withdrawal

There is no right of withdrawal or cancellation right on requests to enrol an event during the commitment period or for a concluded agreements.

Cancellation policy

Participation in an event can be partially cancelled under the following conditions:

Cancellations must be made in writing to contact@intrface.com.

Cancellation must be made no later than 14 days before the start date of the event.

In the event of cancellation, the part of the purchase price that relates to the event itself will be refunded with a deduction of an administration amount of DKK 1000 excluding VAT.

The parts of the purchase price relating to accommodation, catering, entrance fees and other activities included as part of the overall event are only refundable to the extent that Intrface ApS can release itself from its payment obligations already assumed towards partners in relation to such accommodation, catering and other activities.

Refunds are made by issuing a voucher to the customer, which can be used to purchase an alternative event at Intrface ApS. The voucher is valid for 3 years from the date of issue.

Vouchers cannot be paid out, redeemed or exchanged for cash. Section 96 of the Danish Payment Services Act is thus waived.

Price and payment

All prices are exclusive of VAT unless otherwise stated. The total price to be paid, including any VAT amounts, etc. is always calculated and stated before finalisation and completion of the order.

Inthrface ApS makes reservations for price changes, proofreading errors, incorrectly stated prices and other conditions that may result in information of incorrect or not applicable prices on www.inthrface.com. Inthrface ApS can thus unilaterally change prices until an agreement is concluded.

The price includes the services listed in the description of each event in the order confirmation.

Payment must be made online when submitting request for participation using Dankort, Visa/Dankort, MasterCard, Visa or MobilePay. Or via bank transfer.

The full amount will be charged by Inthrface ApS when order confirmation is issued.

Customer default of payment

If Inthrface ApS is unable to complete the payment transaction on the used payment card at the time of order confirmation or if the payment is subsequently cancelled, the customer is in default of payment.

If any additional payments for agreed surcharges are not paid on time in relation to the payment deadline set by Inthrface ApS, the customer is correspondingly in default of payment.

If payment by agreement is to be made by other means than an online payment transaction by credit card, the customer is in default of payment if payment is not received on time in relation to the payment deadline set by Inthrface ApS.

If a payment default is not resolved before the start date of the event, Inthrface ApS

may deny the participant access to the event.

In case of payment default, Inthrface ApS is entitled to charge default interest from the due date and until payment is made in accordance with the provisions and interest rates of the Danish Interest Act. The due date for payment of participation in a event is set at the time of submission of order confirmation.

Inthrface ApS' right of cancellation

Inthrface ApS may cancel an event until 14 days before the planned start of the course if Inthrface ApS assesses that there are too few participants enrolled to complete the event in a meaningful way or if other circumstances mean that the event, in Inthrface ApS' assessment, cannot be completed while maintaining a sufficient quality.

In case of cancellation, all amounts paid will be refunded. Refunds are made by issuing a voucher to the customer, which can be used to purchase an alternative certification course at Inthrface ApS. The voucher is valid for 3 years from the date of issue.

Vouchers cannot be paid out, redeemed or exchanged for cash. Section 96 of the Danish Payment Services Act is thus waived.
